Since our founding, our mission has been clear and unwavering: to serve people in need without discrimination. This principle continues to guide our work and remains at the heart of everything we do.




Participants' Employment Status:





Food Bank

- 5,926 individuals served
- 1.4 million lbs of food and household goods distributed through 16,601 visits

Garden (Calendar Year 2025)

- 912 lbs of produce and

Exercise Classes

ADVOCACY HIGHLIGHTS

In our 2024-2025 fiscal year, **3,829 individuals** representing **1,506 households** received advocacy services from Sister Carmen. And **3,043 individuals** in **1,115** of those households received **\$1,172,128** in financial assistance in some of these categories:



1,580 individuals in **578 households** received **\$600,943** in rent, mortgage, or hotel assistance



652 households received **\$444,590** in utility assistance (water, electricity,* gas*) *mostly funded through **Energy Outreach Colorado**



155 households received **\$59,955** for vision assistance



457 households received **\$35,845** in vouchers to our thrift store



257 households received **8,537** bus tickets



338 households received **\$66,762** in miscellaneous financial assistance (e.g., car & home repairs, property taxes, dental & moving expenses)

Nurturing Parenting Program

- 84 adult household members (62 parents) participated in 5 Series (3 English [1 at Boulder County Jail], 2 Spanish)

Active Parenting of Teens

- 24 adult household members (16 parents) participated in 2 sessions (1 English, 1 Spanish), benefitting 59 children

Circle of Parents

- 42 participants with 81 children met weekly (except for holidays) for approximately 48 weeks

Dare To Be You

- 11 of 12 adults graduated from one bilingual class

Family Leadership Training Institute (FLTI)

- 7 adults graduated from this 20-week civic engagement and leadership course

Bridging Digital Divides

- 235 adults participated in 29 sessions
- 171 devices were provided

Digital Support

- Over 530 hours of digital navigator support was provided to 189 community members.

YEAR IN REVIEW

Sounding the Alarm on the Safety Net

In October 2024, Sister Carmen Community Center joined partners in the Boulder County Family Resource Network to raise urgent awareness about deep cuts to the community’s social safety net. Boulder County reduced its Community Partnership Grant program by \$4.4 million for 2025, and Sister Carmen alone experienced a 25% reduction in our typical county contract—at a time when more families than ever were seeking support. Our CEO, Suzanne Crawford, joined fellow nonprofit leaders at an **October press conference** to share how these cuts would impact local families and to invite the community to stand with us through giving, volunteering, and advocacy.

Immigrant Resource Fair

In November, SCCC hosted an Immigrant Resource Fair that brought together 19 partner agencies, more than 40 volunteers, and over 125 community members seeking vital support. Families connected with

Supporting Our Unhoused Neighbors

In January 2025, SCCC hosted a Resource Fair for individuals experiencing homelessness, bringing together community partners to provide immediate, practical support in a welcoming and respectful space. Attendees accessed STI testing, mental health and recovery resources, re-entry support, wound-care kits, harm reduction supplies, menstrual products, toiletries, shower passes, thrift store vouchers, sexual health supplies, coats, and a warm breakfast with coffee. This event reflected our shared commitment to meeting people where they are and ensuring every neighbor is treated with dignity, care, and compassion.

Her kindness, generosity, brilliance, and selflessness have been a guiding light for countless lives transformed through her work.

We're incredibly grateful to Suzanne for 20 years of visionary leadership, compassion, and commitment. From navigating through the COVID-19 pandemic and the Marshall Fire to preparing us for what lies ahead, her leadership has strengthened our capacity to serve the community we love.



Showing Love to Our Volunteers

Volunteering is love in action, and our volunteers are the heartbeat of SCCC! So in February 2025, we showed them some love for a change! We celebrated their incredible contributions with a “Voluntines” Breakfast filled with joy, good food, and gratitude.







Every time a volunteer stocks a shelf in the food bank, greets someone at the front desk with a smile, sorts items at the thrift store, pulls weeds in the garden, shares their skills with a class, or takes care of behind-the-scenes details, they are making a positive impact on our community. We are so grateful for our volunteers who show up week after week with open hearts and willing hands.



Meeting Hunger with Compassion and Creativity

This year, our food bank navigated significant changes, including the loss of dedicated food bank funding and rising costs from affordable suppliers. In response, we leaned even more on the generosity of our community through food drives and donations—finding creative ways to stretch every dollar while continuing to serve our neighbors with dignity and care.



Despite these challenges, we expanded access by adding Tuesday morning hours for special-needs shoppers, introduced Narcan availability in the food bank, and offered harm reduction trainings in both English and Spanish for staff, volunteers, participants, and community members. As need continued to rise, our food bank saw an increase in monthly visits—underscoring both the growing strain on families and the importance of a reliable, compassionate place to turn.



Powered by Partnership



This year, SCCC strengthened key partnerships that helped families access critical tools for stability and self-sufficiency. Our collaboration with Benefits in Action supported participants in enrolling in public benefits, while the Community Resource Center’s voter outreach team helped eligible community members register to vote directly in our food bank. We also invited Ricardo Cabrera from My Wealth Being, a financial literacy nonprofit, to begin offering workshops and one-on-one financial coaching to participants—expanding access to practical, empowering financial education. He also presented a session to Sister Carmen staff.



Partnering to Provide Utility Assistance



Through our utility assistance programs, SCCC helps families stay housed, safe, and connected to essential services like heat, electricity, and water. This year, we partnered with the City of Lafayette, Energy Outreach Colorado (EOC), LEAP, and other local resources to provide **456 energy assistances**, supporting **1,371 household members** with over **\$323,000** in relief—an average of nearly **\$710 per household**.

For families facing medical crises, job loss, or unexpected hardship, this support is often a lifeline:

"Like many, asking for help was hard. My recent medical problems had financially put me in a hard spot. Thanks to this program, I have my head above water."



A Community Tool for Housing Stability

As a member of Boulder County’s Family Resource Network, SCCC collaborated with Boulder County Housing & Human Services, Emergency Family Assistance Association (EFAA), All Roads, and OUR Center this year to launch **Boulder County Community-Wide Rentals**—a shared online tool designed to help families more easily search for affordable housing options.



The team received a 2025 Community Impact Award from the National Association of Counties (NACo). We’re especially proud of Colin, our Food Bank Advocate, for playing a key role in creating and maintaining this vital resource for East County. This project reflects the power of partnership and our commitment to making critical information more accessible for families navigating housing instability.



Community-Wide Available Rentals

Deepening Our Support for Families

As families face increasingly complex challenges, we are shifting from one-time assistance to deeper, long-term Family Development support. This approach allows us to work alongside families over time, offering personalized guidance that reflects their unique needs and pathways toward stability.



Here When Our Community Calls



This year, our front desk team tracked **4,357** calls from community members seeking support—each one representing a person looking for help, answers, or reassurance. While these numbers don't capture every interaction, they reflect the trust our community places in Sister Carmen to be responsive, compassionate, and present. For many, simply reaching a real, caring person on the phone makes all the difference.

Participant Advisory Committee: Building Community and Strengthening Voices

Sister Carmen Community Center’s Participant Advisory Committee (PAC) continues to play a vital role in strengthening community connection and informing organizational improvement. In 2024–2025, PAC members helped host joyful, inclusive Community Fun Events—including a Movie Night and Clothing Swap (August 2024), a Rock Creek Farm outing (October 2024), and a Día del Niño celebration (April 2025). Through a partnership with Boulder County Parks & Recreation, families also experienced a trip to the mountains—many for the first time—highlighting the importance of access, belonging, and shared experiences.

Beyond events, PAC members engaged in meaningful dialogue that directly contributes to positive change at Sister Carmen. These conversations included early planning for a participant texting platform, a building walk-through to assess safety, accessibility, and welcoming spaces, and discussions centered on climate equity. Together, PAC members continue to elevate participant voices, foster connection, and help ensure Sister Carmen remains responsive, inclusive, and community-led.

Arts, Culture & Community in Action

Throughout the year, Sister Carmen Community Center celebrated the power of art to build connection and belonging by making it accessible to all.



Through our partnership with The Cultural Caravan, we hosted and participated in a Zimbabwean Marimba Workshop featuring renowned artists Zivanai Masango and Blessing Chimanga, invited families to live performances across Lafayette, and held a Ritmo Jazz Latino concert in our own garden—creating joyful, inclusive experiences for our neighbors.







During our garden concert, we also unveiled new murals by local artist [Sarah Spencer](#). The murals, made possible by a City of Lafayette grant, seriously upgraded our garden shed and helped transform our outdoor space into an even more inviting, vibrant gathering place.



In addition, the arts community rallied behind SCCC through benefit concerts and creative fundraisers, including Jingle Jam with the Colorado Bluegrass Music Society, the Front Range Funny Fest, and the Artists in Action art sale, raising critical funds to support our programs. Together, these efforts reflect how creativity, culture, and community can come together to build connection, belonging, and lasting impact.

Organizational Cultural & Education Committee: Living Our Mission



In 2024–2025, Sister Carmen’s Organizational Cultural and Education Committee (OCEC), formerly the JEDI Committee, continued to deepen staff learning, reflection, and connection as a core part of fulfilling our mission to serve without discrimination. OCEC invited community partners and staff leaders to facilitate trainings and conversations that strengthened cultural awareness, empathy, and understanding across our organization.

These efforts included presentations and collaborations with The Latino Chamber of Commerce, Rocky Mountain Equality, Count Me In, and the Interfaith Organizing Director of AFSC’s Denver Immigrant Rights Program, as well as a session with Ignacio Out & Equal Alliance on access to feminine hygiene products.

Staff also learned about Nonviolent Communication (NVC) through a presentation led by Community & Family Education Manager Julie Piller, following her sabbatical studying NVC and through Cultural Presentations during which team members shared their own histories, cultures, and lived experiences. In February 2025, staff participated in a JEDI Bootcamp in-service day at Cleo Parker Robinson Dance, further reinforcing learning through reflection and movement.
